NOTIFICATION

The Lieutenant-Governor, Puducherry is pleased to approve the Scheme of Distribution of dual purpose poultry to farmers under 50% subsidy for backyard poultry production in the Union territory of Puducherry as appended to this Order for implementation in the Union territory of Puducherry. It shall come into force with immediate effect.

1. The Veterinary Assistant Surgeons of the Veterinary Dispensaries of the respective regions shall put up a notice at their office about the dual purpose poultry distribution prior to receipt of the dual purpose poultry from the farm and collect necessary requisition from farmers having backyard facility.

2. The Veterinary Assistant Surgeons of the Veterinary Dispensaries of the respective region shall themselves ascertain the eligibility of the farmers by collecting a copy of the ration card of the farmer requesting for the dual purpose poultry and then distribute the birds on first come first serve basis.

3. The Veterinary Assistant Surgeons of the Veterinary Dispensaries of the respective regions shall keep a record of distribution of the birds with and the beneficiary list and provide all necessary health service to the farmers.

1. Recovery and cancellation of subsidy.— The beneficiary shall submit an undertaking that he/she will continue to rear the dual purpose poultry at least for 12 months from the date of receipt from the Veterinary Assistant Surgeons for egg production and 2 months for meat production. He shall not sell away the stock and shall not use the stock for the purpose other than for which the subsidy is provided.

If it is proved / found subsequently that the beneficiary is a defaulter and has misused the subsidy, the cost of the subsidy so provided shall be recovered by the Government.

Interpretation and clarification.— In the implementation of the scheme, if any doubt arises with regard to the interpretation of any of the provisions of the scheme or if any point requires clarifications, the matter shall be referred to the Director of Animal Husbandry and Animal Welfare, Puducherry and the decision of the Director shall be final.
