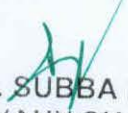
Sub: DAH&AW, Puducherry – Purchase of Medicines and equipments
from Government of India Institutions / Government of India undertaking
firms for the year 2018-2019 – Rate called for – Reg.

The Department proposes to purchase medicines and equipments from the Government of India Institutions/ Government of India Undertaking firms directly or through their branch offices. Therefore, competitive rates of medicines and equipments are invited for the year 2018-2019 from the above institutions for the supply of Veterinary Medicines.

1. The rates are invited only from the Government of India Institutions/ Government of India undertaking firms. Therefore, the participating bidder must furnish a proof of document showing their identity whether it is Government of India Institutions/ Government of India undertaking firms.
2. The rates quoted must be valid for one year from the date of opening of quotation.
3. The rate quoted must be for the unit mentioned in the proforma pricelist supplied by the Department. The details of packing unit available may be marked in the remarks column.
4. Rates must be quoted only for the item readily available for supply throughout the period. Proof of marketing and handling must be furnished in the form of copies of license, sample labels etc., showing composition and packing unit details.
5. The rates quoted must be F.O.R. Destination Puducherry and Karaikal and must be inclusive of all charges, admissible tax payable by the Govt. only will be paid. Revision of rates will not be allowed under any circumstances.
6. Rates must be furnished only in the prescribed proforma (one original + one photocopy), all column of the proforma must be legibly typed. The brand names if any must be shown separately.
7. Attested copies of relevant license for the products quoted issued under Drug and Cosmetic Act must be furnished. The Product quoted by the Government firm must be legibly marked in the Drug license. For items not covered under Drug License, a proof of composition details must be furnished as samples, labels showing composition of ingredients and manufacturing license issued by the competent authority.

8. The Security deposit amount of Rs.20,000/- must be paid by the participating firm. The amount must be paid as demand draft in favour of Senior Accounts Officer, Department of Animal Husbandry and Animal Welfare, Puducherry drawn from a Nationalized bank and payable at Puducherry. The previous Security deposits paid, if any, in respect of any Tender with this Department, will not be considered for this Tender.
9. Documents such as Trial Reports in support of the quality of Product, if any, may also be furnished for consideration.
10. The supply should be delivered either at the Central Veterinary Medical Stores and Vaccine Depot, Animal Husbandry and Animal Welfare Complex, Puducherry – 605 001 or to the Joint Director, Department of Animal Husbandry and Animal Welfare, Karaikal as specified in the supply order within 15 days on receipt of the order.
11. The supplier while submitting the quotation should clearly indicate the local distributors/ agents for the supply. The Tenderer should supply the drugs, medicines and equipments as per the indent in full and piecemeal supply will not be entertained.
12. Each and every drug to be supplied should have minimum shelf life of 18 months from the date of supply. Each medicine and pack shall conform to the standards for Drug and Cosmetic Act, 1940. All items should be packed only in first hand boxes. All the labels including the individual labels of the unit formulations should bear the seal "P.G.S – Not for Sale".
13. If the firm supplies defective items, the firm will be debarred from the subsequent tenders and appropriate penal action will be taken. Failure to supply either a portion or entire quantity intended is liable for forfeiture of the Security deposit.
14. If any of the items quoted by the Government firm is covered in any of the DGS&D rate contract Government-e-Market (GeM) and Pharmaceutical Purchase Policy mode that item will not be considered in the tender even after finalization of selection list of medicines.
15. The Department of Animal Husbandry and Animal Welfare has the absolute right to reject the tender without assigning any reasons.
16. The quotation must be addressed to the Director, Department of Animal Husbandry and Animal Welfare, Maramalai Adigal Salai, Puducherry – 605 001 and must reach this office on or before 26.03.2019 (5.30 p.m.).
